AMENDMENT NO. ONE TO THE UNIVERSITY OF COLORADO HEALTH AND WELFARE TRUST

WHEREAS, The Regents of the University of Colorado, a body corporate and a state institution of higher education of the State of Colorado (the "University"), the University of Colorado Hospital Authority, a body corporate and political subdivision of the State of Colorado ("UCH"), and University Physicians, Incorporated, a Colorado nonprofit corporation ("UPI"), and E. Jill Pollock, Darryl W. Varnado, Kelly Fox, Anthony C. DeFurio and Elizabeth Kissick as the initial named Trustees (hereinafter referred to collectively as the "Trustee"), entered into the Declaration of Trust and Agreement to establish the University of Colorado Health and Welfare Trust (collectively the "Trust") effective June 28, 2010; and

WHEREAS, a Trust Committee has been appointed pursuant to Section 3.1 of the Trust; and

WHEREAS, Section 9.1 of the Trust reserves to the Trust Committee the power to amend the Trust;

NOW THEREFORE, the Trust is amended effective January 1, 2011, or such later date that the health risk assessment program becomes an additional program under the University of Colorado Health and Welfare Plan, to read as follows:

- 1. The words "Exhibit A" are replaced with "an Exhibit" in the first WHEREAS clause under WITNESSETH.
- 2. The phrase "as initially set forth in Exhibit A" is replaced with "as set forth in any Exhibit to the Trust" at the end of Section 2.2.
- 3. Section 2.17 is amended by deleting the last sentence and replacing it with the following:
 - "In the event the University of Colorado Health and Welfare Plan fails to designate a Plan Administrator, the Plan Administrator shall be the Trust Committee."
- 4. Section 2.18 is amended in its entirety to read as follows:
 - "2.18 'Self-Funded Benefit Plan' means a Benefit Plan provided under a self-funded arrangement as set forth in the component benefit plans under the University of Colorado Health and Welfare Plan, which were determined by the Employers."
- 5. Section 7.1 is amended by deleting the word "initial" and replacing the words "Exhibit A" with the words "an Exhibit" in the first sentence.
- 6. The words "Exhibit A" are deleted and replaced with the words "an Exhibit hereto" in Section 13.4.

- 7. The phrase "set forth in Items 1-4 of Exhibit A" is replaced with the phrase "under the University of Colorado Health and Welfare Plan" in Section 13.10(h).
- 8. Exhibit A is replaced in its entirety as follows:

- 6. (a) Health Care Flexible Spending Account Component of The University of Colorado Flexible Benefits Plan ("University Flex Plan")
 - (b) Pretax Premium Component of the University Flex Plan with respect to Health Premiums for the Component Benefit Plans listed in Items 1-5 of this Exhibit A
- 7. (a) Health Care Spending Account Plan of the University of Colorado Hospital Authority Cafeteria Plan ("UCH Cafeteria Plan")
 - (b) Pretax Premium Component of the UCH Cafeteria Plan with respect to Health Premiums for the Component Benefit Plans listed in Items 1-5 of this Exhibit A

Item 6 is sponsored by the University. Item 7 is sponsored by UCH. The Trust is the funding vehicle for Items 6 and 7."
