NOW THEREFORE, the Trust is hereby amended effective July 1, 2018.

1. Section 2.7 is amended in its entirety to read as follows:

"Dependent' means an Employee's dependent, which may include the Employee's spouse, domestic partner, and partner in a civil union (pursuant to the Colorado Civil Union Act, C.R.S. § 14-15-101 et seq., as may be amended from time to time), as defined under the terms of the applicable Benefit Plan, who satisfies the requirements for eligibility under and participation in the Plan."
